A Message from Adminstrative Coodinator Loomis

After two years concentrating on SRT's organizational transition and improving team operations and systems, 2018 saw a shift in focus to the sustainability of the organization. While preparing the following year's operating budget, SRT began developing a five-year capital improvement plan program. As part of this process, we worked with the Mechanics Team to evaluate our current capital assets to determine what is not essential to our teams' operations. This resulted in the Joint Administrative Council (JAC) deeming several assets, such as the rehab bus, forklift and its trailer, as surplus. We arranged for these items to be sold at auction, the proceeds of which were given to the MABAS divisions to put toward future capital needs.

To help ensure the longevity of our current capital assets, the Mechanics Team and myself developed and implemented an annual preventative maintenance/service schedule for all of our assets. In addition, we used SRT's contingency fund to purchase and begin outfitting a replacement Mechanics Truck to provide the team with a more reliable vehicle. We also upgraded the Sonar Team's technology, which included the purchase of a new tablet and two tablet-style laptop computers to operate the sonar equipment.

As will be SRT's annual practice, the team leaders/coordinators, operations chiefs and myself spent several weeks reviewing and updating all eight standard operating guidelines (SOGs). This year's review focused on revising and consolidating all of the forms contained in the SOG appendices, many of which have been converted into fillable PDF documents. Together with MABAS Divisions 4 and 5, SRT also updated the special team box card templates and guides to reflect changes made to the SOGs.

We closed out 2018 with a plan to continue the discussion on organizational sustainability by engaging in a strategic planning process in the new year. This process will lay out a plan for SRT's future and identify new goals and tasks to ensure our special teams are prepared and equipped to meet the needs of its member agencies moving forward.






2018 Highlights
