Chairman's Report

- Replacement JAC Member (MABAS Division 5): Deputy Chief Spraker introduced Chief Paul Klicker (Spring Grove Fire Protection District) as the new JAC member from Division 5.
- Replacement Operations Chief (MABAS Division 5): Deputy Chief Spraker shared that
 Operations Chief Williams will be stepping down from his role as of the August 1, 2023 JAC
 meeting. He reached out to the MABAS Division 5 President to start the process of finding a
 replacement.

Secretary/Treasurer's Report

Chief Greg Formica (Secretary/Treasurer) presented the minutes for the May 2, 2023 meeting for approval. A motion was made by Chief Kreher, seconded by Chief Steingart to approve the minutes. Administrative Coordinator's Report

Administrative Coordinator Loomis presented her report. She reported that there were seven new team members this month and gave an overview of the training for May 2023. She reported on two incidents since the last meeting. The Sonar Team was called on May 7, 2023 to Somers, WI but was cancelled enroute. The Hazardous Materials and Mechanics Team responded on Woodstock to May 29, 2023 for an ammonia leak. She also gave an update on a few administrative items including (1) interviews for three leadership positions on the Technical Rescue Team, (2) the scheduling of a roll-off truck model committee meeting in July, and (3) Division 4 Water Rescue & Recovery Team Leader Bill Lark's desire to step down from his position as of June 30, 2023.

- MABAS Division 4: Operations Chief Buschick gave an update on the Division 4 teams. A copy of Chief Buschick's report was included in the meeting packet.

- <u>2024 Budget Request Preparations</u>: Administrative Coordinator Loomis reported that the team leaders have started preparing their 2024 budget requests. The budget review will take place at the August and September JAC meetings.

• <u>Status of One-Year Tasks & Assignments</u>: Discussion occurred regarding the priority one-year tasks and assignments from SRT's Strategic Plan.

• <u>Wildland Task Force Vehicle</u>: Operations Chief Buschick reported that he is working with the team leaders on a written proposal to present at an upcoming JAC meeting.

New Business

- Annual Review of Standard Operating Guidelines (SOGs): Discussion took place regarding the proposed updates to the Administrative and team SOGs. Several revisions were discussed. Final approval will take place at the August JAC meeting.
- <u>Level A Hazardous Materials Suit Purchase (Contingency Fund)</u>: A motion was made by Chief Kreher, seconded by Chief Steingart to approve the purchase of 12 level A hazardous materials suits from Air One Equipment, Inc. in an amount not to exceed \$14,480 to be taken from SRT's contingency fund. Roll call vote: 5 AYES, 0 NAYS. Motion carried.

Items for the Good of the Membership

• <u>Division 4 Deployment Shelter Request (Highland Park)</u>: Chief Steingart reported that the Highland Park Fire Department has requested the use of the Division 4 deployment shelter for an event on July 4.
