A Message from Administrative Coordinator Christina Loomis


In 2022, SRT spent much of the year refocusing on its strategic planning efforts. In May, SRT held a strategic planning workshop to evaluate, discuss and update its 2020 strategic plan. Members of SRT's Joint Administrative Council and both MABAS Division Boards, the Operations Chiefs, and the special team leaders/coordinators attended this workshop which began by reviewing the progress made over the past two and a half years in each of the five goal areas. Attendees were amazed to see the number of administrative and operational accomplishments achieved since the plan was adopted – and spent most of the day updating and outlining new tasks to continue moving SRT forward in each of its goal areas. In August, SRT adopted an updated strategic plan that will guide the efforts of the organization for the next few years.

One of SRT's most important accomplishments in 2022 was implementing the 5-Year Capital Improvement Plan, which was approved by both MABAS Division 4 and MABAS Division 5 in 2021. This included incorporating the program into the annual budget review process for the first time so that both the operating and capital budgets are presented together each year. This change allows SRT to consider both the small and large needs of its teams every year and better prepare for future projects in a comprehensive manner. It also provided opportunities for the MABAS divisions to recognize projects that could receive outside funding or identify ways to collaborate to share resources more efficiently.

As the Illinois Office of the State Fire Marshal began rolling out recertification requirements for firefighters, SRT worked with the training officers from MABAS Division 4 and MABAS Division 5 in 2022 to begin tracking training objectives for special team related certifications. SRT updated its training sign-in sheets for the SRT Hazardous Materials and Technical Rescue Teams and centralized data entry of training objectives for these teams into an enterprise training site for all members to access.

As has become an annual practice, SRT reviewed and updated all eight of its Standard Operating Guidelines (SOGs) and associated forms in 2022. We also continued our efforts in succession planning by expanding the team leadership groups for several teams and appointing team members to fill vacated spots. SRT's website also received several significant updates. The website was updated to include both video and podcast capabilities and content – and now includes educational, marketing, and recruitment focused content. All these projects, both big and small, continue to improve SRT and ensure that the organization meets the needs of its member organizations. While a great deal has been accomplished over the past few years, the updated strategic plan demonstrates the many areas that require continued improvement in 2023 and beyond.

Responsible for controlling and mitigating hazardous materials incidents, including identification, assessment, containment/confinement and decontamination.



2022 Highlights

Coordinated a county-wide drill utilizing the Union Pacific Railroad's training cars.

Responded to Spring Grove for an incident involving recalled chlorine tablets. Distributed a safety notice to the team on the incident, including recommended safety procedures, given the widespread nature of the issue.

Hired three outside instructors to provide targeted team training in areas such as RIT (rapid intervention team) and decontamination.





Mechanics Team

Responsible for supporting all other teams during both training and incidents, by ensuring all assets (vehicles and equipment) are operating properly and reliably on a day-to-day basis.

Technical Rescue Team

Responsible for managing special rescue situations in the areas of rope rescue, confined space, structural collapse and trench rescue.

Water Rescue and Recovery Team

Responsible for all incidents involving bodies of water and includes three disciplines: dive, sonar and swiftwater.

Dive

Responsible for the rescue and/or recovery of drowning victims (often also assists with evidence recovery).

Purchased new LiveScope sonar equipment and installed a new computer and two new monitors on the sonar boat.

Responsible for incidents involving swift moving or flood water.
