A motion was made by Chief Kreher, seconded by Chief Klicker to approve the updated 2024 2028 CIP as presented. Roll call vote: 6 AYES, 0 NAYS. Motion carried.
- <u>Disposition of Old Sonar Boat & Trailer (Surplus Equipment)</u>: Discussion occurred regarding the disposition of the old sonar boat and trailer. The JAC directed Administrative Coordinator Loomis to offer the old boat and trailer to the SRT member departments for their purchase. Sealed bids will be opened at the October JAC meeting. If no bids are received, SRT will send the boat to auction.
