A motion was made by Chief Steingart, seconded by Chief Kreher to approve the final budget report as presented, with \$6,296.89 being assigned for contingency and \$43,452.67 being assigned for future capital purchases. Roll call vote: 6 AYES, 0 NAYS. Motion carried.
- <u>2023 End of Year Training Forms Report</u>: Administrative Coordinator Loomis reported on the status of SRT members in relation to their End of Year Training Forms. The Joint Administrative Council directed Administrative Coordinator Loomis to proceed with the roster changes as presented.
