



## WATER RESCUE & RECOVERY TEAM

Responsible for all incidents involving bodies of water and includes three disciplines: dive, sonar and swiftwater.

#### DIVE

Rescue and/or recovery of drowning victims (often also assists with investigations and evidence recovery).

#### SONAR

Searches bodies of water for victims and/or evidence using side and sector scan equipment.

Responsible for incidents involving fast moving and flood water rescues.

Responsible for managing special rescue situations in the areas of rope rescue, confined space, structural collapse and trench rescue.
